As we close out 2017, we at the Physicians Foundation have a lot to be thankful for despite the continuing uncertainty the healthcare industry faces. We are very proud of all we have accomplished this year. Most recently, we issued the findings from our second <u>Patient Survey</u>, provided \$1,000,000 to help rebuild physician practices impacted by the record-breaking hurricane season and presented at a number of forums including the 2017 American Conference on Physician Health and Direct Primary Care Conference.

Looking toward the future, the Physicians Foundation responded to the Centers for Medicare & Medicaid Services (CMS) recent request to provide

recommendations on the Center for Medicare and Medicaid Innovation's (CMMI) "new direction." As an organization representing physicians throughout the country and the patients they serve, we are grateful for this opportunity and applaud CMMI's continued commitment to advancing patient-centered care. It is crucial in this next era of CMMI that physician and patient voices remain at the center of the conversation, and central to the design and implementation of CMMI initiatives.

What we shared is very much in line with the Physicians Foundation's mission to empower physicians to lead in the delivery of high-quality, cost-efficient healthcare. By focusing on a broader notion of health, rather than just treating and managing illness, we believe that CMMI can achieve its goal of enabling quality care at reduced costs with improved outcomes. The proposal, which you can find on our website, provides three specific recommendations:

- 1. Recognize the impact of poverty and other determinants on health by naming the need to address health-related social needs as a guiding principle
- 2. Improve care delivery and reduce burdens faced by physicians by simplifying and consolidating existing and future payment and care delivery models through an embedded focus on health-related social needs
- 3. Support state-level innovation that incorporates prospective financing and health-related social needs into payment and care delivery models

We look forward to learning more about CMMI's plans for the future and are honored to represent the voice of the physician on critical issues facing the country's medical care.

Focus On: 2017 Patient Survey

The Physicians Foundation recently issued its second Patient Survey, to take the pulse on how Americans are feeling when they step out of the doctor's office. The survey, conducted by Regina Corso Consulting in June 2017, gathered responses from a national sample of 1,747 U.S. adults between the ages of 27 and 75 who had two visits with the same doctor in the past year.

A number of the questions from the survey corresponded to similar questions from the Foundation's 2016 Biennial Physician Survey, in order to compare patient and physician outlooks on the healthcare landscape. Topline findings include:

- 95 percent report satisfaction with their primary care physician
- 70 percent of consumers believe their physician has the ability to influence the healthcare system
 - However, 41 percent of physicians believe they have little ability to influence the healthcare system
 - 75 percent are concerned about their ability to pay for medical treatment should they get sick or injured (compared to 62 percent in 2016)
 - 69 percent believe insurance companies have the greatest influence in impacting treatment options
 - » Contradicts with whom consumers (87 percent) feel the true influencer should be, which is physicians

The results have generated numerous trade and top-tier media articles and more than 30 new followers to the Foundation's Twitter handle. As with the Physician Survey, we expect interest and coverage to continue through 2018 as reporters look for strong reference points to root their stories.
